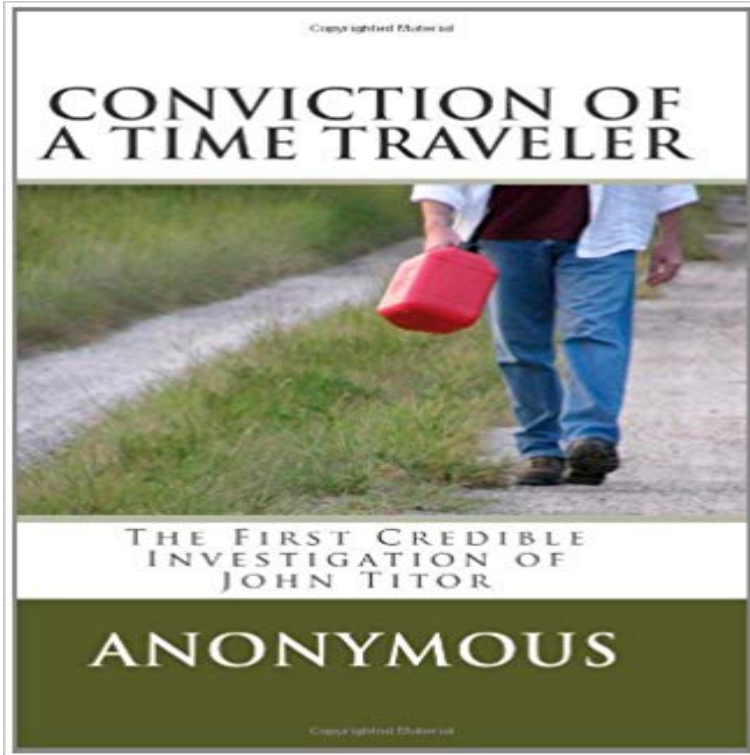


Conviction of a Time Traveler
