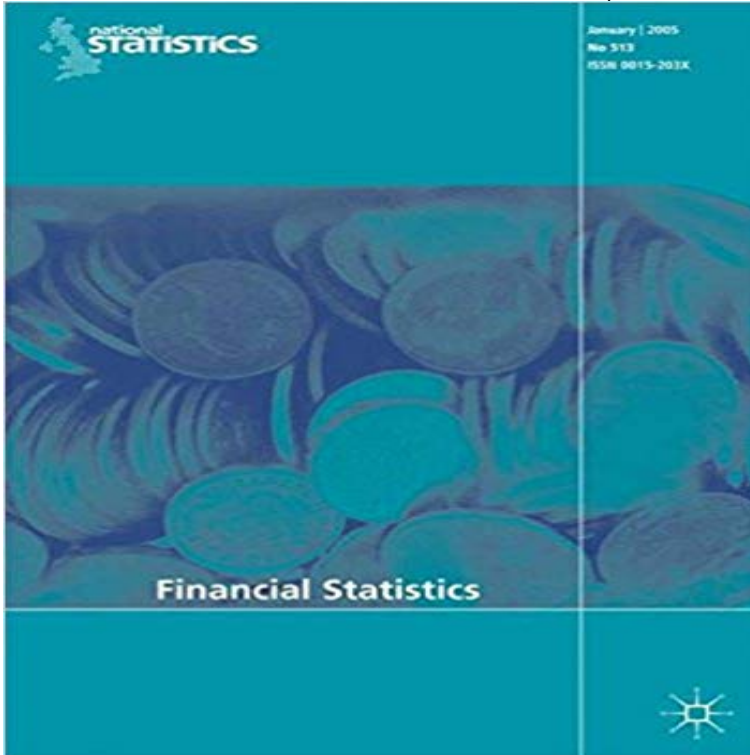


Financial Statistics No 519 July 2005
