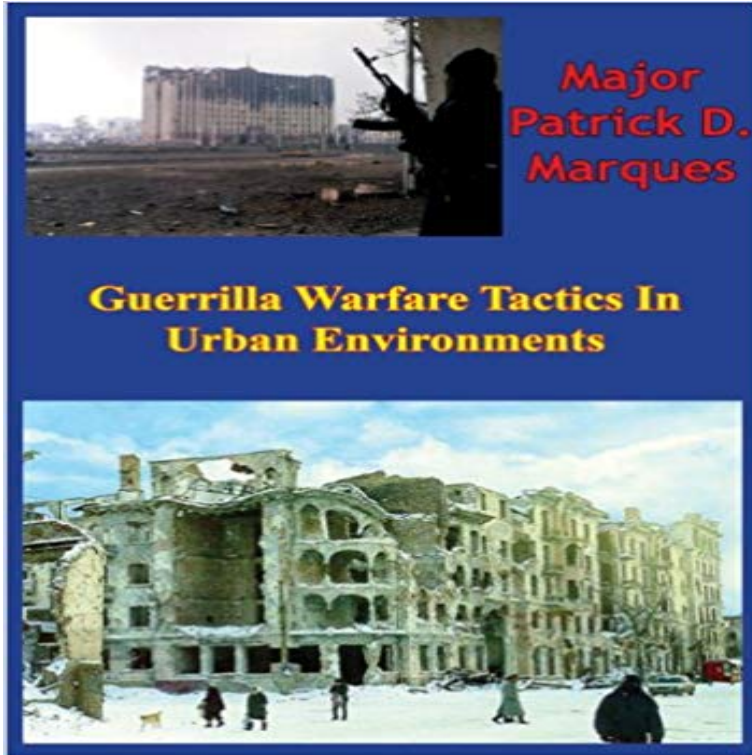

Traditionally, Special Forces guerrilla warfare doctrine has focused on its conduct in a rural environment as historically, most guerrilla movements have formed, operated, and been supported outside of the cities. Increasing world urbanization is driving the center of gravity of the resistance, the populace and their will to resist, into urban settings. As populations have gravitated to the cities on every continent, the ability to prosecute a successful guerrilla war has often depended on the ability to conduct combat operations in these environments. Predominantly, the aspects of unconventional warfare that were executed in urban settings were those such as intelligence activities, recruiting, sabotage, or subversion. Guerrilla warfare combat operations were done in urban environments only when absolutely necessary.
